And Whereas the protection and longevity of the Handivan Transit Vehicle is a shared interest among the participating municipalities;

And Whereas the creation of a building reserve fund dedicated to the development of a protective structure or garage for the Handivan is a proactive and cooperative measure to safeguard this critical regional asset from environmental damage and ensure its continued operation;

Therefore Be It Resolved that the LGD of Pinawa supports the establishment of a reserve fund by Two Rivers, with the express purpose of financing the construction of a protective structure or garage for the Handivan Transit Vehicles;

And Be It Therefore Be It Resolved that this initiative be pursued in partnership with the Rural Municipality of Lac du Bonnet and the Town of Lac du Bonnet, with all three municipalities collaborating in support of this shared infrastructure investment.
